DFN LM26 TERMS & CONDITIONS

Please read these Terms and Conditions carefully as they apply to your participation at the Doctors For Nutrition Lifestyle Medicine Conference 2026 (DFN LM26).

By attending, speaking, exhibiting, or sponsoring at DFN LM26, you agree to be bound by the Terms and Conditions below, which form a legally binding agreement between you and the Conference host (DFN LM26). As a condition of attendance, delegates must agree to adhere to all health and safety measures put in place by DFN LM26.

DFN LM26 organisers reserve the right to publish changes to these Terms and Conditions without prior notice.

PAYMENT OF REGISTRATION

The registration payment is by credit card only at the time of registration.

The Australian goods and services tax (GST) at 10% applies to all goods and services offered by the Conference. All registration fees listed include GST.

DISCOUNTED REGISTRATION FEES

Pre-early bird and Early bird registration fees

Pre-early bird discounts are available from 28 February until 31 March 2026.

Early-bird discounts are available for tickets purchased between 1 April and 31 May 2026.

If registration fees are not received by 31 May 2026, your registration will revert to the standard Conference registration fee.

Full registration

Delegates must purchase a full-day registration for the Conference program on Saturday 28 November 2026. No half-day registrations available.

Student rates

The Student Rate applies to students enrolled at a tertiary education institution at the time of registration. A valid document, e.g., a student ID card or letter issued by the

school/university/institution, must accompany the student's registration and be valid through 2026.

Concession rates

The Concession Rate applies to low-income Healthcare Card holders, or Seniors Card holders, at the time of registration or who have either card valid in 2026. A valid document, e.g. a physical card or letter issued by the government, must accompany the concession registration.

TRANSFER OF REGISTRATION

If you are unable to attend, you are welcome to transfer your ticket to another person. You must notify the event organisers so that ticket details can be updated.

If you are an international visitor and your application for a visa to enter Australia is unsuccessful, the above cancellation terms apply.

Transfers can be made by the registered person in writing to the Conference organisers at events@doctorsfornutrition.org no later than 14 November 2026. Details must include the replacement person's full name, their title, contact phone number and email address. Unless otherwise specified, all other registration details will be carried over to the new person.

LATE REGISTRATION

While every effort will be made to accommodate all participants, ticket sales will close **two weeks** (after 14 November 2026) prior to the Conference commencement date, as final commitments to catering and materials may have been made. CANCELLATION OF THE REGISTRATION BY THE DELEGATE/SPONSOR

Please choose carefully when purchasing tickets or sponsorship options for the event. We do not offer refunds for change of mind, scheduling conflicts, or personal circumstances.

Refunds will only be provided as required by Australian Consumer Law. You may be entitled to a refund or exchange if the event is cancelled, significantly rescheduled, or materially changed in a way that substantially alters the nature of the event you purchased tickets/sponsorship for.

If the event is postponed, your tickets/sponsorship will generally remain valid for the rescheduled date. If you are unable to attend the new date, you may request a refund in accordance with Australian Consumer Law.
